

1st Annual National Yearling & Ewe Lamb Sale

Rules and Regulations

1. Sale will be held January 22, 2012 at 2:00 p.m. in the National Western Stock Show SH1 (Sheep barn.)
2. Each exhibitor can sell two head, either two yearling ewes or two ewe lambs or the combination of one yearling ewe and one ewe lamb. All sheep must be bred and raised by the consignor. All ewes must meet the rules of the National Western Stock Show Sheep Division and entered and exhibited in the Sheep Show.
3. The consignor has to indicate if the ewes are bred or open. If they are bred the breeder has to provide a breeding certification that is acceptable by the Breed Association and must accompany the registration transfer. If the ewes are not registered (cross bred wether dams, Natural Colored) then the seller must provide a breeding certificate indicating the ewe is bred and identify the sire.
4. All sheep entered in the sale will be identified as to their Scrapie Resistance DNA Genetic Codon at 171 (QQ, QR, RR). They are required to have an official APHIS Scrapie Tag in their ear.
5. At the consignor's option they can provide Fleece Grade information and ultrasound data relating to carcass value.
6. All sales will be between the seller and buyer. National Western Stock Show & Rodeo will not be responsible or involved in or liable for any dispute between the Buyer and Seller regarding the Sheep sold.
7. All sheep consigned to the Sale must be representative of the individual breed and be fitted accordingly. If the consignment does not meet these standards the sheep in question can be sifted from the sale. Any entry fees will be retained by the sale committee.
8. All sheep entering Stock Show grounds must have a current health certificate within 30 days. Each ewe consigned to the sale will be identified by flock tag number and APHIS Scrapie Tag number on the health certificate.
9. The Sale Committee reserves the right to reject any or all entries and the entry fee will be returned.
10. **ENTRY FEES:** The entry fee is non-refundable and must be included at time entries are received. An entry fee of \$20.00 per head and a commission charge of 10% of the sale price on all animals. A late fee of \$40.00 will be charged per entry after December 20th 2011. Regular Commission will be charged on "No Sale Animals" and be calculated from the closing bid. Entry fees will be retained on animals entered and not brought to the sale, animals not sold in the ring, or screened.
11. **TERMS OF SALE:** Sales are to be settled before moving animals from pens, cash or cashable check, no credit cards.

12. Consignors will be responsible for lot numbering on animals according to the catalog. The animals should be lot numbered before showing. Paint and irons are provided. **All substitutes must be marked with a bar below the number.** The Sale Committee will be in charge of the sale order.
13. The Committee will make every effort to protect both buyers and sellers in every reasonable way, but under no circumstance do they, or the National Western Stock Show assume any liability. The auctioneer will settle misunderstandings as to bids made. **All Sales are final.**
